



PRESS STATEMENT

FOREIGN EXCHANGE AUCTION ALLOTMENTS AND FOREIGN EXCHANGE PAYMENTS FOR OCTOBER 2023

In line with its commitment to regularly keep the public informed of developments in the foreign exchange market, the Bank hereby advises that: -

1. The sum of US\$8 549 370 was allotted to 248 beneficiaries under the Retail Foreign Exchange Auction during the month of October 2023 and the sum of US\$56 742 924.60 was allotted to 773 beneficiaries under the Wholesale Foreign Exchange Auction during the month of October 2023.
2. Total foreign exchange payments for October 2023 were US\$840 673 625 broken down as follows: -
 - (i) foreign currency accounts (US\$770 264 427);
 - (ii) Foreign Exchange Auction Allotments (US\$65 292 294.60); and
 - (iii) the interbank market (US\$5 116 903).
3. The bulk of the retail auction allotments during the month of October 2023 (58%) was for payment for raw materials (US\$2 723 192) and machinery and equipment (US\$2 212 894), with the remaining 42% of the total allotments going towards payment for services (US\$1 255 800), consumables (US\$799 142), retail and distribution (US\$1 012 010), pharmaceuticals and chemicals (US\$181 068), paper and packaging (US\$218 741) and fuel, electricity and gas (US\$146 523).
4. Total cumulative foreign exchange auction allotments since inception of the Foreign Exchange Auction System stand at US\$4 108 719 769.
