



## **UPDATE ON RESERVE MONEY**

**AS AT 22<sup>ND</sup> APRIL 2022**

## RESERVE MONEY

1. Reserve money for the week ending 22<sup>nd</sup> April 2022 remained unchanged from the previous week's position of ZW\$29.16 billion.
2. The increase of ZW\$964.08 million in statutory reserves was offset by declines of ZW\$867.82 and ZW\$97.88 million in banks' liquidity at Central Bank (RTGS balances) and currency issued, respectively.
